The undersigned hereby releases Highbridge Voices Corp., its respective directors, officers, and employees from any claim arising out of any medical treatment the Child may require.

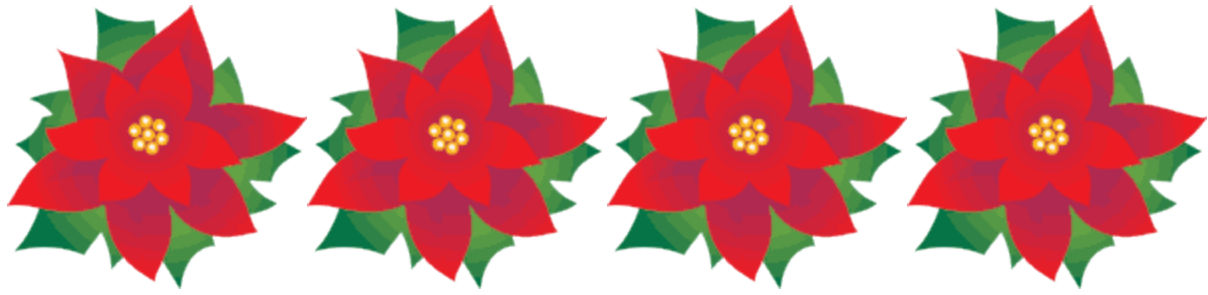

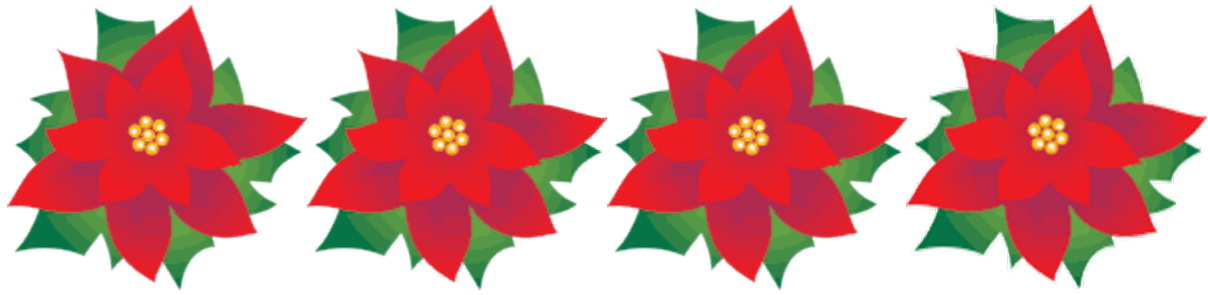
